A.M. Clinic on Friday, October 17, 2008

Title: Developing Authentic Literacy Experiences in Social Studies: The Storypath Approach

Facilitator: Dr. Margit McGuire, Seattle University

This clinic will have an advanced registration. Attendees will be required to pay \$10.00 for the clinic and be required to register for the conference to gain admission to the clinic. You will receive advanced confirmation of your spot.

This clinic focuses on teaching literacy in social studies, demonstrating how Storypath creates purposeful lessons that all students find engaging. Storypath uses narrative creating meaning and contextualizing the application of literacy. Participants will receive copies of curriculum (The Nation Divided) which they will be able to use with their students following the clinic.

Subject Areas: American History and Civic education

The Clinic objectives are to introduce the Storypath approach and demonstrate strategies for developing reading and writing within the context of the approach, explore how the use of narrative enhances student engagement and creates “the lived experience” and how such experiences engage students—especially students from low-performing backgrounds, and demonstrate a specific topic—the Civil War—and how it is used with the Storypath approach.

Social studies often suffers from “marching through a topic” --students see no purpose or connection from one bit of information to the next or any relationship to their own lives or any reason to read and write well in social studies. The challenge is to create powerful social studies lessons that clearly articulate a purpose that students find compelling, worthy of their time and effort and in which they authentically apply reading and writing skills as they enhance understanding of a social studies topic.

In the Storypath approach, a narrative is constructed to connect subject matter for a topic into a sequence of learning experiences. Students participate in their learning experiences from the viewpoint of a character in the narrative. They engage in role-play that treads a path between imagination and reality, constructing their understandings about the subject matter.

In this clinic, participants will be introduced to an historical topic and explore how students use their imagination to think about another time and place. Thus, Storypath relies on plot as a way to organize historical content and the application of literacy skills to contextualize learning. Plot by its very nature piques students' curiosity and sets the stage for questioning: What happens next? Which way will things turn out? What should we do? When students are the characters in the plot and must answer these questions, they become engaged and create personal meaning from such experiences—so critically important for students of low socio-economic backgrounds. Participants will explore aspects of this approach in the workshop and be given curriculum that explains the approach in depth.

P.M. Clinic on Friday, October 17, 2008

Title: Clinic: Deliberation for Collaborative Solutions

Facilitator: Dr. Harris Sokoloff, University of Pennsylvania

Duration: 1:15 p.m. to 4:15 p.m.

Maximum number of attendees: 30

This clinic will have an advanced registration. Attendees will be required to pay \$10.00 for the clinic and be required to register for the conference to gain admission to the clinic. You will receive advanced confirmation of your spot.

This clinic focuses on teaching democratic deliberation in the social studies classroom and curriculum. If democratic deliberation is at the heart of our representative government, then how does it happen if it is not taught. Deliberative democracy rests on the core notion of citizens and their representatives deliberating about public problems and solutions under conditions that are conducive to reasoned reflection and refined public judgment; a mutual willingness to understand the values, perspectives, and interests of others; and the possibility of reframing their interests and perspectives in light of a joint search for common interests and mutually acceptable solutions.

Subject Area: Civic education

Clinic participants will explore ways to engage students and fellow teachers in the use of non-partisan deliberative activities to frame and work through issues which are important to them (school, local, regional, national and international).

The Civic Mission of Schools Report recommends incorporating discussion of current events and controversial issues into classrooms, as a way of promoting student intellectual engagement and civic learning. It further suggests that civic learning extend to classes other than the traditional civics courses. This clinic will respond to that recommendation.

The workshop will provide:

- * Experience in nonpartisan deliberative discussions on real world issues.
- * Educators with information about best practices for using deliberation in high schools.
- * Educators with ways deliberative forums address local, state and national standards.
- * A problem-solving and mentoring network for teachers.
- * A way of linking texts to rich conversation, supporting literacy learning.
- * Content and strategies for engaging students in active authentic discussions -- in ways that are productive, intellectual and academically stimulating.
