WPCSS presented the Albert Goldsmith Awards for the best exhibit featuring local History at the district History Fair competition at the Heinz History Center. Matt Bosack of Shaler Middle School received the junior division certificate and a \$100 bond for his presentation on the 63rd Pennsylvania Infantry Regiment of the Civil War which was recruited in Pittsburgh. The senior section was won by Mackenzie Martin whose exhibit entitled *15 minutes of Fame* focused on Andy Warhol. In both cases, the exhibits were pleasing to the eye, had legible captions, and were self explanatory. Mackenzie also received a bond and a certificate. In addition to the awards given to the winning students, WPCSS grants a complimentary membership to each teacher sponsor who participated in the History Fair.

WPCSS is currently renewing memberships and searching for new members. Our roster at present has about 60 members including comps. Much of our activity is confined to on-line communication. Our web-site provides links to materials in various social studies, especially history where videos and slide shows are available. Our monthly news letter, *The Point*, reaches about 1000 people, courtesy of Soldiers and Sailors Memorial Hall. We are looking forward to having a successful membership drive.
