New season of On Our Minds focuses on the election

A special seven-episode season of *On Our Minds*, a teen life podcast from PBS News <u>Student Reporting</u> Labs (SRL), has begun, and you can find the first episode here or wherever you download podcasts.

This season will focus on the issues and impacts of the 2024 election for young people. <u>On Our Minds:</u> <u>Election 2024</u> will include interviews with America's youngest political candidates and cover topics like how students' conceptions of America have changed, the electoral college, who gets to vote and make decisions, free speech and censorship, and how to tackle election disinformation.

New from PBS LearningMedia: WHAT is Media Literacy and HOW Can Simple Shifts Center It?

Media literacy is the ability to access, analyze, evaluate, create, and act using all forms of communication.

Teach media literacy in your classroom and help your students learn to combat misinformation, empower them to ask questions, think critically, and create media in a variety of formats. This article, written by middle school teacher Mary Kate Longergan, introduces three easy-to-implement shifts you can make to help center media literacy within your classroom.

Election 2024 Misinformation Dashboard from the News Literacy Project

The News Literacy Project (NLP) recently debuted their <u>Misinformation Dashboard: Election 2024</u>. This free online resource collects examples of viral rumors, doctored images, conspiracy theories and Al-generated fakes. Election misinformation poses an existential threat to democracy, and individual fact-checks are not adequate to counter this danger.

The dashboard goes above and beyond by doing the following:

- Highlighting of-the-moment data.
- Analyzing common trends and topics within a larger context
- Featuring dynamic visualizations that quickly illuminate information
- Providing educators with real-time examples for the classroom and enhancing the understanding of journalists and researchers diving into election misinformation

Everything on the dashboard is interactive. Click on the two options at the top of the dashboard to explore election misinformation by theme or type. You'll find examples of fabricated or manipulated content, false or misleading context and many forms of Al-generated deceptions. NLP is tracking the trends regarding election integrity, party platforms and the candidates themselves.

Virtual Program: "Antisemitism: Understanding and Countering this Hatred Today"

As part of the Office of Elementary and Secondary Education's ongoing efforts to provide resources related to the Holocaust, Genocide, and Human Rights Violations, we have been able to make a professional development series available to educators (including PDE staff) called "Echoes and Reflections." These professional development opportunities are jointly funded and endorsed by the Anti-Defamation League, the USC Shoah Foundation, and Yad Vashem, and are offered at no cost to participants.
